## **BOARD BRIEFS**

## Action of the Board of Education of Dearborn Heights School District No. 7

At its Regular Meeting on Tuesday, March 21, 2017 the Board of Education discussed/took action on the following item:

- Athletic Director Scott Wiemer provided a written summary of the AHS boys swimming two-year pilot that was approved by the Board of Education in 2015. Mr. Wiemer indicated that during the two seasons, the team struggled due to lack of participation and that season two was ultimately cancelled due to the declining numbers and out of fairness to opponents.
- ➤ Approved the second and final reading of proposed revised Board Bylaws and Policies as presented:

- Approved a four (4) day field trip to compete in the 2017 AASHTO National Design & Build Bridge Challenge in Portland, Maine May 21-24, 2017 for three (3) Annapolis High School drafting/CAD students and two (2) chaperones as presented. Airfare, lodging and meal costs for the student team and one (1) chaperone will be funded by AASHTO sponsors, airfare and hotel for second chaperone will be derived from Perkins grant funds. This trip is sponsored by Mrs. Sweet, drafting/CAD teacher.

- Approved the permanent expulsion (90 days per Michigan Law based on grade level) of a Pardee Elementary School student for violation of the Student Code of Conduct and Board Policies #5500 and 5572.
