

BOARD BRIEFS

Action of the Board of Education of Dearborn Heights School District No. 7

At its Regular Meeting on Wednesday, March 7, 2018 the Board of Education discussed/took action on the following items:

- Mr. Brock, Assistant Superintendent, presented an analysis of the district's business manager position and presented a proposed job description for a full-time business manager for the 2018-19 school year. A resolution followed under "Superintendent's Recommendations."
- Assistant Superintendent Brock outlined three (3) options being considered for future custodial cleaning services, as the district approaches the end of the existing contract with TPG in May, 2018. The three (3) options are: 1) Re-new current contract with TPG; 2) Seek bids for the current services we receive from TPG; or 3) Seek bids for the current services we receive from TPG, with intent to seek bids for district-wide custodial cleaning services at the end of the current custodial contract in 2019. There was a consensus from board members to explore option 3.
- Assistant Superintendent Brock presented information on private security companies. A recommendation to seek bids from private security companies to fill four (4) security positions (two at O.W. Best Middle School and two at Annapolis High School) will be made at the next board meeting.
- Superintendent Jennifer Mast provided an update following the School Safety Community Forum that she held on February 22nd and a March 6th school safety meeting attended by Crestwood, Westwood and District 7 central administration and a team from the Dearborn Heights Police Department.
- Superintendent Mast presented her self-evaluation to the board for discussion.
- Approved a job description for the district's Business Manager position as presented.
- Authorized participation in the Schools of Choice Program as permitted by Section 105/105c of the State School Aid Act for the 2018-19 school year. District 7 will accept grades K-8 limited enrollments and grades 9-12 unlimited enrollments by nonresident students who reside within Wayne County ISD (WCRESA) or contiguous districts as presented:
