## Action of the Board of Education of Dearborn Heights School District No. 7

At its Regular Meeting on Wednesday, May 16, 2018 the Board of Education discussed/took action on the following items:

- And the Michigan Lottery's Educator of the Year is....**Kerri Moccio, PASS teacher at Bedford School!** Since 2014, the Michigan Lottery has bestowed the Excellence in Education Award to a deserving Michigan educator each week. Kerri was selected as the weekly winner in December, 2017 and received a commemorative plaque, a \$1,500 cash prize and a \$500 grant. The lottery also selects one of the weekly winners as the Educator of the Year. Representatives from the Michigan Lottery attended the board meeting and presented Mrs. Moccio with the Educator of the Year Award and a \$10,000 cash prize in recognition of her numerous literacy initiatives in District 7, as well as in her home community. - Supported the 2018-19 proposed Wayne County RESA general fund operating budget.
- Approved an English learner summer school program, facilitated by Wayne County RESA, for grades 1-12 as presented. Monies will be derived from Title III grant funds.
- Approved a public relations and branding package with K-12 Media at a cost of \$9,900 from the General Fund. The package will include functional improvements to our existing website, promotional videos, a new district brand/logo and vector graphics of all school mascots.
